This agreement is between All Aboard Animal Rescue (“AAAR”) and \_\_\_\_\_ (hereafter referred to as the “foster family”). This agreement shall remain in effect for one year unless otherwise noted.

I, the foster family, agree and understand that the dog(s) are the sole property of All Aboard Animal Rescue and All Aboard Animal Rescue reserves the right to remove the dog(s) at any time. I agree to return the dog(s) upon request, or if I am no longer able to care for them.

I agree to provide the dog(s) with care, including food, water, shelter, exercise and medication when required.

I understand and agree to adhere to all relevant zoning and animal control codes and ordinances, whether local, county, or state.

I understand that I am committing to fostering through the next adoption event. I understand that if I am having issues I need to contact AAAR and they will arrange for another foster, but I am responsible for the dog until that time. I agree that I will not drop the dog off anywhere without AAAR consent.

I agree to allow the dog(s) to be available, with a reasonable amount of notice, for viewing by potential adopters. I also understand that, if necessary, AAAR may inspect the area in which the foster dog(s) are kept in the home at any time. In the event of an emergency, I will allow AAAR to an immediate inspection due to natural disaster, fire, suspected illness, endangerment or abuse.

I understand that all medical treatment will be provided by The Animal Hospital of Colorado (970) 267-9333. **Any medical expenses from any other veterinarian not contracted by All Aboard Animal Rescue will NOT be reimbursed.** In the event of an emergency, All Aboard Animal Rescue and the Animal Hospital of Colorado must be contacted before any action is taken.

I understand that AAAR will not be held responsible for any damage to persons, other dogs, or property, done by the foster dog(s) while in my care. I agree to indemnify and hold harmless All Aboard Animal Rescue, its officers and assigns, any previous owner, foster home or shelter, from any and all liability associated with the dog(s) or damage or injury hereafter caused by the dog(s).

The foster family further agrees that they shall not commence or maintain any lawsuit against AAAR as to any and all claims arising out of this agreement. Should the foster family breach this covenant and commence or maintain a legal action against AAAR, then they agree to pay all attorneys' fees, costs, and administrative expenses incurred by AAAR.

I understand that I must notify AAAR immediately if the animal gets loose, hurt or there are any emergencies.

I understand that I must notify AAAR if my living situation, address, roommates, or anything specified on this agreement changes.

I understand that my foster home position can be terminated at any time if my actions or conduct are deemed detrimental to the best interests of puppies placed by All Aboard Animal Rescue. I agree I have read and understand, accept and agree to abide, to the terms and conditions of this puppy foster home contract.
